Biblical Counseling Services Fees for Service Acknowledgement

Dear clients,

The fee for Biblical Counseling services are as follows: \$100.00 for individuals (per hour); \$150.00 for couples (per hour) and \$250.00 for families (per 90 minutes) sessions. Family sessions are reserved to no more than 5 people at a time to ensure everyone has the opportunity to be heard. The financial resources invested into your Biblical Counseling sessions are an investment in you, your marriage, your family, and above all your relationship with Christ.

The fee for group sessions is set at \$90.00 dollars per person, for 3 hours. The topics discussed in group will be predetermined by the ministry; however, influenced by clients' interest. Group sessions run for a period of 3-hours on a monthly basis.

Note: Group sessions are held on the third Saturday of every month (**except for U.S. Federal Holidays**). Group sessions are only available via zoom. The same topic will be offered for two consecutive months to accommodate for group session rescheduling. A minimum of 10 participants are required. If 10 people are not registered 7- days prior to the scheduled event, it will result in rescheduling the group session, pushing the topic to the second and final allotted **month**. Individuals will be notified of the changes via email. ***Please make certain your current email address is on file. You can do so by completing and sending back the brief contact form found on the website. You will be contacted at the same email address used at the time of booking your group session appointment.*** There are no obligations for attending future group sessions. **All sessions are nonrefundable.**

****All Biblical Counseling sessions are non-refundable.** All sessions must be paid in advance. Acceptable forms of payment includes: Cash, Cashapp at (\$Keownpatrick), Credit Cards, Checks, and Zelle (@484-649-5947). **A 3.5% Convenience Fee will be added to all payments made by credit card. This fee will be due at the time of credit card payment and is non-refundable.**

Insurance is not accepted.

All cancellation must be made at least 72-hours prior to your scheduled counseling session. Texting, voice mail messages and emails are acceptable forms of communication for both scheduling, rescheduling and or cancelling your session. ****Please read the full cancellation policy for fees associated with cancellations. Economic hardship should be expressed and evidence provided, so that a "Sliding Scale" fee for services can be considered.**
